The Government of Lebanon (GOL) has received financing from the International Bank for Reconstruction and Development (The "World Bank") towards the Emergency Crisis and COVID-19-Response Social Safety Net Program (ESSN). The objective of the \$246 million project is to provide cash transfers and access to social services to extreme poor and vulnerable Lebanese populations affected by the economic and COVID-19 crises.

The Government of Lebanon (GOL) intends to apply part of the proceeds to consulting services.

The consulting services ("the Services") include the following tasks:

The Third-Party Monitoring Agent (TPMA) will provide independent monitoring of project outcomes and perform ongoing audits on the implementation for Components 1-3 of the project. The key responsibilities are the following:

- A. **Beneficiary eligibility verification**: This includes verifying whether beneficiary households meet the eligibility conditions of ESSN. The verification process will include administering a household survey to determine eligibility.
- B. Audit project implementation: This includes a technical audit on the different aspects of project implementation, including the registration process, status of cash transfers, accuracy of amounts, delays in transfers, etc. The audit will also include reconciling monthly reports provided by WFP with the financial reports of the PCM.

the entire contract, if selected.

(CQS) method in accordance with the procedures method set out in the World Bank Consultant
